**TEAM ENTRY FEE:**

(per participant)

- \$45.00 (member) \$55.00 (non-member)
  - Open to anyone
  - **THREE** kokanee weigh-in per team
  - A TEAM is one or more anglers.
- All team members must be the same boat.
  - One boat per team.

**\*JUNIOR DIVISION ENTRY FEE:**

(per junior participant)

- \$15.00
  - Open to anglers 15 yrs of age and under
    - **ONE** fish weigh-in
    - Must weigh-in separate from team.
  - Junior Division prizes to be announced (\*If a Junior angler decides to fish in a team, then Team Entry Fees apply and cannot participate in Junior Division.)

<b>Fishing Times:</b>	Start: 6:30am (no exceptions)
<b>Weigh-In:</b> Located at Edison Day Use Group Area near launch ramp	Start: 12:30pm End: 2:00pm * You must be in weigh-in line by 2:00pm <b>NO EXCEPTIONS</b>
<b>Lunch:</b> (included with entry fee) Lunch Only (non-fishing entrant: \$15.00)	Begins at 1:30pm

## SHAVER LAKE TEAM DERBY RULES

## **2008 Shaver Lake Team Derby Application**

Please Print Legibly • Please Fill Out ONE Application Per Angler

1. It is the responsibility of each participant to know all the rules pertaining to this tournament.
2. Each derby participant age 16 and older is responsible for obtaining a current California fishing license. All California Department of Fish & Game Regulations apply.
3. All derby entrants must fish from a watercraft which is not anchored, tethered, or shored.
4. **NO FISHING FROM THE BANK IS ALLOWED.**
5. All watercraft must comply with Coast Guard standards of equipment and safety. All Coast Guard boating rules & regulations apply.
6. Any person, capable of handling a fishing rod & reel, accompanying a paying participant in a boat must be entered in the derby.
7. Weigh-in limit:
  - Team Kokanee Limit: 3 kokanee per team
  - Junior Angler Limit: 1 kokanee per junior angler
8. In the event of a tie, the weight of the single largest fish measured & weighed will determine the winner. If a tie still occurs, the length of the single largest fish weighed & measured will determine the winner.
9. All measurements are final once weigh master accepts measurements. There will be NO re-weighs.
10. Tournament officials' decisions are final.
11. The tournament will officially begin for fishing at **6:30** am.
12. Pre-fishing is allowed prior to the day of the derby, however, no fishing allowed prior to the **6:30**am start time.
13. Weigh-in will start at 12:30pm and end at 2pm of each derby day. No late arrivals accepted.
14. Fish must be weighed & measured on the day caught.
15. You are not permitted to hold any fish with the intention of releasing it later for a larger fish. As soon as a fish is caught, you must decide to keep it or release it.
16. Any fish showing signs of tampering or considered questionable by derby officials or employees of the California Department of Fish & Game will be held for inspection and discounted from the derby until derby officials have determined fish as acceptable. Any fish determined to be tampered or augmented **WILL** be held for further inspection by the CDF&G and the responsible angler will be disqualified from the derby.
17. Absolutely **NO** transferring of fish between boats or teams.
18. Professional fishing guides are certainly welcome to participate. However, no professionally guided trips are allowed at any time during the derby.
19. Any persons conducting themselves in a disorderly manner at any time may be expelled from the tournament, and can be denied re-entry to future tournaments.
20. Team Definition: A team consists of one or more anglers. All team members must be in the same boat. **ONE** team per boat.
21. Junior Division: All participants under the age of 16 may enter the Junior Division.
22. Failure to comply with any of the above said rules will result in entrant's disqualification.
23. In the interest of Sportsmanship and Fairness to all, and to promote the fun and family atmosphere of this event, the above may be amended on a single case basis at the discretion of the derby chairperson.
