Car audio enthusiasts will think that this is a promotion for Kicker amplifiers, speakers, or subwoofers. Bass fisherman will think that this article is about winning strategies and breakdown how to get a kicker, or big fish, to help win bass tournaments. However, this is "The Kokanee Kronicle," which means that a "kicker" is a reference to a small auxiliary outboard engine that is usually used for low speed operation such as trolling.

For 2013, Kokanee Power has a brand new Yamaha 9.9 HP High-Thrust Four-Stroke outboard motor to raffle off! A special thanks goes to Victory Yamaha Outboards and Power Products in Petaluma, CA. This engine will include electric start and power trim, and the winner will have the option of choosing either the tiller handle version or with remote controls. Make a Difference in Fishing Regulations

As anglers and avid outdoorsmen, have you ever questioned certain sport fishing regulations put forth by our state's Department of Fish and Wildlife (DFW), formerly called the Department of Fish and Game? For example, for all lakes in the Valley District such as Lake McClure, New Melones, Don Pedro, and Pardee, the bag limit is only five Kokanee and only five Kokanee in possession. Lakes in the Sierra District like Stampede and Donner, you are allowed a bag limit of five Kokanee but 10 Kokanee in possession. Have you ever thought it would be great if the DFW increased bag and possession limits for certain lakes to ease the threat of overpopulation and small Kokanee?



Kokanee anglers have a voice, and we have the ability to make those changes! Below is a link documenting how Kokanee anglers can participate in the DFW's sport fishing regulatory process.

At a high level, recommendations for sport fishing regulations originate from the public, department staff, the Fish and Wildlife Commission, Fish and Wildlife Advisory Commissions, and local governments. These recommendations are then evaluated within the appropriate DFW region and by the Fisheries Management Committee. If the proposal passes evaluation, DFW prepares a regulation change recommendation for the Fish and Wildlife Commission to consider. Through a series of meetings held by the Fish and Wildlife Commission, the public has the opportunity to comment on the proposed regulation change. At the end of the public process, the Fish and Wildlife Commission may approve the regulation change.

In past years, the Fish and Wildlife Commission was only hearing sport fishing regulation proposals every three years. However, the frequency has been now changed to accept regulation proposals every year!
