TEAM DIVISION INFORMATION:

- Open to all anglers
- A TEAM consists of one or more anglers.
- All team members must be in same boat.
- One team per boat.
- Anglers 15 yrs of age & under who register in the Team Division are not eligible to participate in the Junior Division & are required to pay Team Div. Fees.

TEAM WEIGH-IN INFO:

- **FOUR** fish weigh-in per team per day
- Salmon, Rainbow & Brown Trout
- Only **ONE** Brown Trout and **TWO** King Salmon allowed per team per day

**JUNIOR DIVISION

JUNIOR DIVISION INFO:

- Open to anglers 15 yrs of age and under.
- Anglers registered in the Junior Division are not eligible to register in the Team Division.

JUNIOR DIVISION WEIGH-IN INFO:

- **Two** fish weigh-in per day (salmon or trout).
- Only **ONE** Brown allowed per day.
- Must weigh-in separate from team

REGISTRATION by mail, email, online, or phone only. No registration on site. Please mail completed registration no less than 7 days prior to the derby date OR register by phone, email or internet. No Check-In required before fishing.

Fishing Start Time: 6:00am (Saturday & Sunday)

WEIGH-IN: at the **BASSHOLE BAR AND GRILL**, Lakehead, Ca

Saturday 4:00pm to 5:00pm

Sunday 2:00pm to 3:00pm

Allow yourself enough time to return to the weigh-in. No late arrivals will be allowed.

DINNER & RAFFLE: LAKEHEAD LIONS CLUB at 7:00pm on Saturday evening. No host cocktails start 6:00pm. Dinner included with paid entry.

SHASTA LAKE TEAM TOURNAMENT RULES

1. It is the responsibility of each participant to know all the rules of this event.
2. Only rainbow trout, brown trout, and king salmon may be weighed in.
3. Daily team weigh-in limit: 4 fish per day (of which only 1 may be a brown trout and/or 2 may be a king salmon). Daily Junior weigh-in limit: 2 fish per day (of which only 1 may be a brown trout and/or 2 may be a king salmon).
4. All fish weighed in must be caught the day of the event.
5. All fish weighed in must show signs that they are freshly caught and not held from a previous outing. Warm and faded fish will be withheld at the weigh master's discretion. Keeping fish on ice is highly recommended.
6. All registered entrants must fish from a watercraft which is not anchored, tethered, or shored. No fishing from the bank is allowed.
7. No jigging is allowed.
8. At the request of the Shasta Lake Marina Owners, NO fishing is allowed within the marina buoy lines of each marina.
9. All California Department of Fish & Wildlife Regulations apply.
10. All California Department of Boating and Waterways Rules & Regulations apply.
11. Any person, capable of handling a fishing rod & reel, accompanying a registered participant in a boat must be registered in the event. No ride alongs allowed.
12. A **Team** consists of one or more anglers. All team members must be in the same boat. **ONE** team per boat.
13. A **Junior** participant is any Kokanee Power member under age 16. Any Junior participant may register as part of a team OR in the Junior Division but not both. Junior anglers participating as part of a team must register as an adult. Junior non-members will require a \$15 membership fee.
14. In the event of a tie, the weight of the largest single fish measured & weighed on Sunday will determine the winner. If a tie still occurs, the length of the single largest fish weighed & measured on Sunday will determine the winner.
15. All measurements are final once weigh masters accept measurements. There will be NO re-weighs. All weigh master decisions are final.
16. Pre-fishing is allowed prior to the day of the event, however, no fishing is allowed prior to the event start time on the day of the event.
17. You are not permitted to hold any fish with the intention of releasing it later for a larger fish. As soon as a fish is caught, you must decide to keep it or release it.
18. Absolutely NO transferring of fish between boats, teams, or participants.
19. Professional fishing guides are certainly welcome to participate. However, no professionally guided trips are allowed if registered in the event.
20. Any persons conducting themselves in a disorderly manner at any time may be expelled from the event and can be denied entry to future events.
21. Failure to comply with any of the rules will result in disqualification.
22. Weigh-in will start at 4:00pm & end at 5:00pm on Saturday and start at 2:00pm & end at 3:00pm on Sunday at the BASSHOLE BAR & GRILL in Lakehead, Ca. No late arrivals accepted.
23. The tournament will officially begin at: **6AM each day**
24. In the interest of Sportsmanship and Fairness to all, and to promote the fun and family atmosphere of this event, the above may be amended on a single case basis at the discretion of the derby moderator.
